**INTRODUCTION OF THE MUNICIPAL BUDGET**

**BE IT RESOLVED**, by the Mayor and Council of the Borough of Glen Ridge, in the County of Essex, New Jersey that the following statements of revenues and appropriations shall constitute the Municipal Budget of the Borough of Glen Ridge for the 2025 calendar year;

4. Total General Appropriations (Item 9, Sheet 29)	<b>\$ 18,485,307.94</b>
5. Less: Anticipated Revenues Other than Current Property Tax (Item 5, Sheet 11)	<b><u>\$ (4,259,604.94)</u></b>
6. Difference: Amount to be raised by Taxes for support of the Municipal Budget (as follows) (a) Local Tax for Municipal Purposes including Reserve for Uncollected Taxes (Item 6(a), Sheet 11)	<b>\$ 14,225,703.00</b>

**BE IT FURTHER RESOLVED**, that said Budget will be published in the **April 17, 2025** edition of the Glen Ridge Paper.

**BE IT FURTHER RESOLVED**, that the Mayor and Council of the Borough of Glen Ridge does hereby approve the preceding as the Budget for the 2025 year:
