



**ORDINANCE NO. 1805**

**BOND ORDINANCE REAPPROPRIATING \$824,000, INCLUDING \$823,140 OF PROCEEDS OF OBLIGATIONS NOT NEEDED FOR THEIR ORIGINAL PURPOSES AND \$860 FROM THE CAPITAL IMPROVEMENT FUND, IN ORDER TO PROVIDE FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE BOROUGH OF GLEN RIDGE, IN THE COUNTY OF ESSEX, NEW JERSEY.**

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF GLEN RIDGE, IN THE COUNTY OF ESSEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. Pursuant to N.J.S.A. 40A:2-39, it is hereby determined that \$823,140 of the proceeds of obligations originally made available pursuant to the following sections of Bond Ordinance #1718 of the Borough of Glen Ridge, in the County of Essex, New Jersey (the "Borough"), finally adopted September 9, 2019, are no longer necessary for the respective purposes for which the obligations previously were authorized. The down payment in the amount of \$860 is also no longer necessary for its original purpose.

Section 3(b)(2)	<u>Public Works Yard:</u> Replacement of a salt shed, rehabilitation of the storage barn and the acquisition of storage containers, including all work and materials necessary therefor and incidental thereto and further including all related costs and expenditures incidental thereto.	\$1,054.77
Section 3(d)	<u>Hurrell Field:</u> Rebuild stairs to the basketball court, including all work and materials necessary therefor and incidental thereto.	\$1,300.00

Section 2. \$824,000 of the \$824,044.77 proceeds described in Section 1 and made available pursuant to N.J.S.A. 40A:2-39 (including the \$860 from the Capital Improvement Fund) are hereby reappropriated to provide for the various capital improvements below:

<u>Municipal Complex:</u> Point, paint and repairs, including all work and material necessary therefor and incidental thereto.	\$151,070

<u>Public Works Yard:</u> Refinish shop floors and painting of all main building exterior doors and trim, including all work and materials necessary therefor and incidental thereto.	\$12,680
<u>Freeman Tennis Courts:</u> Various improvements, including, but not limited to, the installation of exterior and interior fencing, renovations to court 7, rehabilitation of building, the replacement of the storage shed and upgrades to the irrigation system and further including all work and materials necessary therefor and incidental thereto.	\$40,650
<u>Public Works:</u> The acquisition of vehicles, including, but not limited to, a mason dump truck, an international truck, a jitney, a vactor truck and a sport utility vehicle and further including all related costs and expenditures incidental thereto.	\$50,600
<u>Public Safety:</u> The acquisition of radios, including all related costs and expenditures incidental thereto.	\$102,000
<u>Administration:</u> The replacement of a gas pump, including all related costs and expenditures incidental thereto.	\$67,000
<u>Roads and Streets:</u> Road & streetscape improvements, including all work and materials necessary therefor and incidental thereto.	\$400,000
<b>Total</b>	<b>\$824,000</b>

Section 3. The amount of \$44.77, representing the amount made available pursuant to Section 1 and the amount reappropriated pursuant to Section 2, is hereby cancelled.

Section 4. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 5. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.
